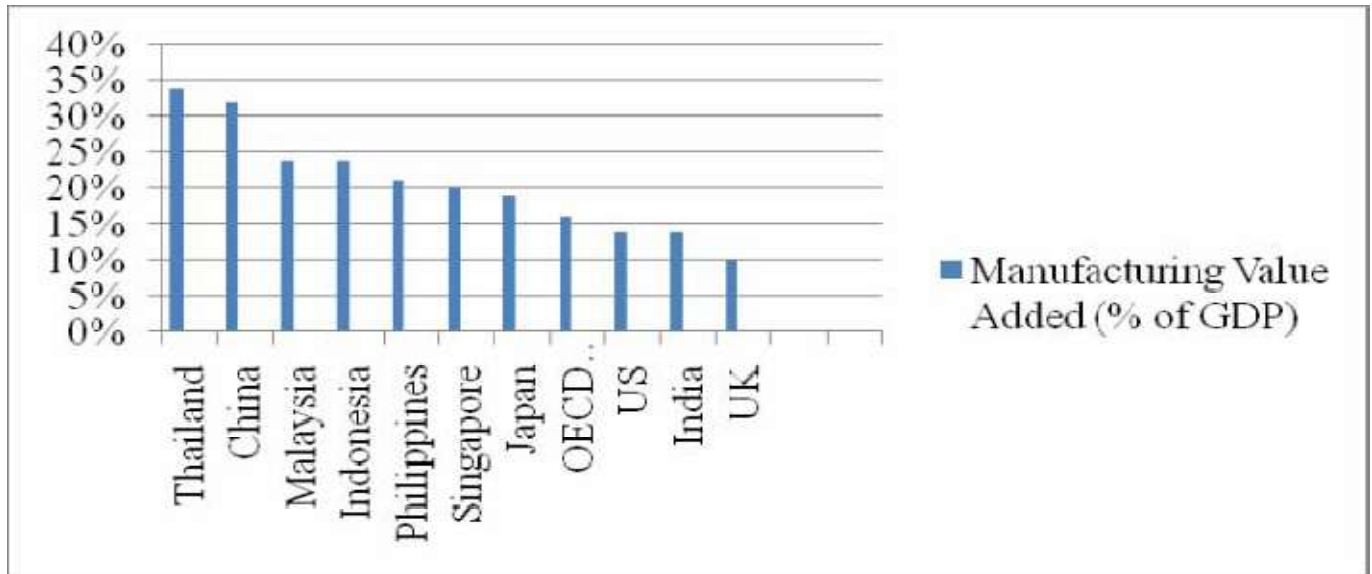
INTRODUCTION
