#### ABSTRACT:

This study examines the socio-economic status of migrant workers in the Mumbai metropolitan region. Weanalyse the patterns of income, consumption and savings and the nature of work of migrant workers in the Mumbai metropolitan region, based on data from a sample of 400 migrant workers. We find that informalinformation networks across the hometown migrant workers play an important role in the migration of workersto the Mumbai metropolitan region. Poor economic conditions in the hometown, high salaries and betteremployment in the Mumbai metropolitan region have been identified as the main reasons for migrating to the Mumbai metropolitan region. While there is almost no change in the nature of migrant employment, even aftermigration, there has been a shift from low-income classes before migration to high-income classes aftermigration. Despite improving income levels, the living conditions of most migrant workers are miserable, withmost living either in poor rented apartments or on construction sites with no sanitation facilities. adequatelygiene.
